3.1 Ethical Business Conduct

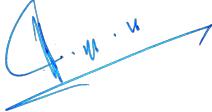

3.8 Contribution to Economic Development

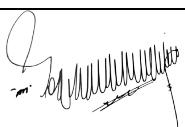
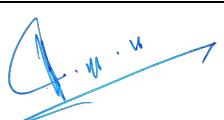
RGSS supports economic growth by creating employment opportunities, supporting local service providers, strengthening the private security sector, and investing in staff training and financial empowerment.

5. Monitoring and Evaluation

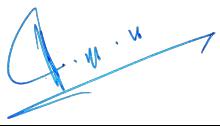
RGSS monitors CSR performance through reviews, community feedback, environmental indicators, and internal audits. Findings inform improvements to CSR initiatives.
